# Transportation - Our Life Blood

Marie Mills Center drives many miles every year in the provision of services to individuals in our program. On average, we drive close to 90,000 per year, taking people to work, medical appointments, community events, and other local services as well as making special trips to the valley for various needs. In all, Marie Mills Center operates 10 vehicles and puts them to very good use. In fact, the Marie Mills Center shares vehicles with Tillamook County Special Olympics for their out of town events. Having good quality vehicles is very important.

In March we received a brand new Eldorado National Aerotech Bus which will become our primary vehicle for our vocational program transportation services. Funding for this vehicle came from grants from the **Public Transit Division, the Tillamook Association for Retarded Citizens, and the Collins Foundation.**

While Marie Mills Center travels many miles in its mission to provide services and meet the needs of those in our programs, we could not do it without the help of others. Because

of support from the **Public Transit Division, the Siletz Tribal Charitable Contribution Fund, and Tillamook Association for Retarded Citizens,** these past 6 years we were able to purchase tokens from our local transportation system "The Wave" and distribute them to program participants and others with disabilities within our community so they could use public transit. This is an excellent opportunity for individuals to learn how to use public transit and have their worlds opened up even further through public transportation.

## Generator Project

As anyone who lives on the Oregon Coast knows, we have more than our share of weather related emergency situations ranging from high winds to floods. Because of these situations, we took a long hard look at emergency planning and things that we could do to enhance the safety and comfort of those in our programs and others during emergency situations. The main thing that came out of this was that our largest residential facility would be well served by having a **whole house generator.**

Through donations from **State Farm Insurance, Aaron Dunn Insurance, Carl Peters, Jill & Darryl Carter,**

and the **Coon family,** we have raised nearly \$14,000 of the \$23,000 needed to make this project a reality. We are approaching various grant sources to fund the remainder of this project and are keeping our fingers crossed that funding will be in hand by our next winter season.

The accomplishment of this project will assure that the needs of the individuals living at that location are met. This also creates capacity to meet the needs of other individuals with disabilities, not living at that home, who need a place of refuge on a temporary basis during such an emergency.

# Consider The Marie Mills Foundation When Planning Your Estate




