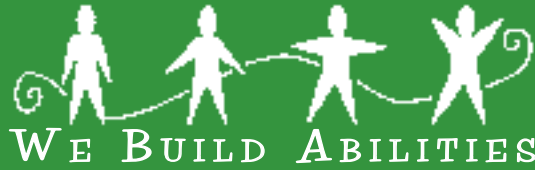

The Year in Review

Since 1969 we have served individuals with intellectual & developmental disabilities through meaningful life experiences that are integrated within the community, and opportunity filled. Last year, **our residential program served 38 individuals** through our Madrona House & Nestucca House group homes, and our Supported Living program. **Our vocational program served 69 individuals** providing opportunities such as job training, supported employment services, and Alternatives to Employment services for individuals who no longer desire to work due to age and other factors.

As those in our programs age, they become increasingly medically involved. Because of this, it is easy to understand the **need to prioritize medical care for those served**. In our program, last



year alone, **we took individuals to 343 doctor visits**.

Staff members are **our most valuable asset**. **The list of what our caring staff does for those served is very lengthy, often going beyond the call of duty or a job description**. We are extremely fortunate to have **a stable staffing compliment that is experienced in serving those with special needs**. As an example, the average tenure in our agency is 11 years. Our management team of 5 individuals has a combined 125 years of tenure with Marie Mills Center. This is not a common occurrence in our field. The stability, tenure, and experience within our agency directly contributes to quality services provided to those we serve.

As an agency, our biggest strength is that we continue to have no long term debt. We own all of our facilities. This allows us to focus our resources on client services. The “great recession” impacted everyone greatly, in particular non-profit social service agencies. Since that time, **we had operated with a 6% funding reduction from the State of Oregon** as well as not having funding provided for staff COLAs. Within the past year **we saw the restoration of the 6% funding cut** from the State allowing us to provide staff wage increases which was most welcomed.

Integrating individuals with intellectual & developmental disabilities into the community for jobs and life experiences are the guiding principles for programs like

ours. For this to happen, transportation resources are key. **The scope of transportation services provided by MMCI is large**, with 10 vehicles **we travel nearly 100,000 miles annually**.

To keep our facilities in shape, **we have a very active maintenance program** spending nearly \$50,000 annually. Highlights from the year include building a ramp at our Nestucca House Group Home.



We replaced many of the cedar siding panels at our Front Street facility that were worn & cracked, and also finished interior painting. We also replaced a section of siding on our Madrona House Group Home.

New priorities at the State level (see “A Changing Service System in Oregon” on page 3) virtually assure that every individual with an intellectual or developmental disability in Oregon receives some form of service. Because of this we have seen many more requests for services from families & individuals who had not previously been served. Also changing priorities at the State level stress development of employment for those with disabilities. We have been focusing on enhancing our responsiveness to all requests as well as our overall flexibility in providing traditional and non traditional services to meet these priorities.

During 2013/2014 we updated all of our agency computers to Windows 7 and we also implemented a telephone time keeping system. It was a busy year.

Priorities for 2014/2015

Adapting to new priorities will be our major focus. It is important for us to broaden outreach to community employers to generate employment opportunities for those with disabilities. As well as to prepare ourselves to serve more referrals for various services as **we anticipate continued increases** for such. **Both areas of change indicated above encompass non traditional approaches that will be required of programs like ours. This will be our top priority in 2014/2015.**

Marie Mills Foundation Update

A Changing Service System In Oregon

Many changes were recently ushered in by the State of Oregon for individuals receiving services from programs like ours. These include the **Employment First Initiative which prioritizes employment opportunities for individual with intellectual and developmental disabilities**. Many system changes have been implemented to make this a reality in programs like ours. While we are no stranger to placing individuals into community based employment opportunities, with this initiative, we and others like us will **increase our emphasis on finding community based and integrated jobs for the individuals we serve**. Key tenants to this initiative are the belief that everyone can work with supports, and employment opportunities should be the first choice for all individuals with intellectual & developmental disabilities. We look forward to continuing and enhancing our efforts at placing individuals into community based employment opportunities.

Also the State has initiated another initiative called Community First Choice Option (The K Plan). This provides the State with the authority to **expand person centered and community based services for individuals with intellectual and developmental disabilities**. This plan provides a 6% increase in Federal matching funds to

the State to go towards its implementation. The Community First Choice Option will allow programs in Oregon to continue breaking down barriers to keeping people in

their own homes. Some of the new services that will be funded by this include helping individuals maintain a safe and clean living environment and expanded use of technologies to facilitate independent living. It will also allow programs like ours to **develop new community based care options that meet the needs of these individuals**. In the

past, to receive residential services individuals often needed to be in a crisis in order to get comprehensive services from a program like ours. The Community First Option allows programs to provide more supports to individuals without going through the crisis process as well as having services uniquely tailored to their needs.

These two initiatives represent a major increase in service levels and opportunities for those with special needs in our state and is a major evolutionary step in Oregon's history of integrating individuals within their communities.



A Very Busy Summer



It has been a very busy summer for all, in particular our vocational program with our **Cape Lookout Park contract** being implemented as well as the normal increases in work opportunities. Additionally this summer we were awarded the contract for cleaning the **Forest Interpretive Center**, which will be a major contract that provides more steady work opportunities for those we serve. Adding to our busy summer is the fact that individuals in our vocational program as well as staff take summer vacations making it a very exciting time for manning various crews. All in all, we have done well in meeting the needs out there during this very busy time. Also this summer, **we purchased a riding lawn mower** for our lawn maintenance crew to use in maintaining our contracts which will enhance our abilities.

Nestucca House Generator Project

Marie Mills Center recently received a grant for **\$5,000 from the Samuel S Johnson Foundation** to help in the purchase of a whole house generator for our Nestucca House Group Home. As you may recall, several years ago we engaged in a similar campaign to have such

a generator installed at our Madrona House Group Home. The cost of the new generator will be \$32,000. With this grant in hand we are half way to our goal of funding with confidence that we will succeed in raising the remaining amount by the end of this year.

Summer Time Fun Picnic

This year, as in others, our annual picnic was well attended and enjoyed by all. On August 16th under a beautiful sunny sky, many smiling faces enjoyed hamburgers and hot dogs along with potato and macaroni salads, chips and cookies.
