

knowledge and experience with our residential services and we look forward to her leading this program forward



A Wild Winter for All!

Anyone that lives in Tillamook County can tell you it was a **wild winter**. In November, heavy rainfall caused local rivers to exceed their banks and flood. Because of this heavy rainfall a city storm drain adjacent to our Front Street facility collapsed creating a **sinkhole next to our building**. If that was not bad enough, drainage from our

Front Street facility roof that drains into that storm drain was blocked because of the sinkhole causing drainage to back up out of our downspout drainage, collecting water in our 30 foot planter, and blowing out its brick retaining wall. The picture on the right provides a good visual on this. If you look close enough to can see water shooting out of the drainage intakes close to our building.

Not to be outdone, that storm was soon followed by a bigger storm and flood event in December which completely surrounded our Front Street facility with flood water. Fortunately, this event caused no damage to our facility.

Gwen was a tireless advocate and supporter of programs for the intellectually and developmentally disabled in Tillamook County.
