### Trask House Begins Services


On December 1st we opened up "Trask House", a residential service providing 24-hour staffing/care to two

individuals. Services are identical to group home services but occur in a much smaller and homelike setting. We have been working on this project for over a year. A lot was involved with this including staffing, outfitting the home, staff training, and licensing with the State, as well as locating and gaining

control over the site. Two individuals moved from our other group homes into this new setting and are loving

it. The House Manager of Trask House is Joanie Snyder who has extensive experience working in this field. The movement statewide is for smaller residential settings that are as homelike as possible. Future plans include spinning off additional individuals from our Madrona House group home into similar residential service settings like this.

# Confidential Record Destruction Ending Soon

For years confidential record destruction services were performed by individuals with intellectual and developmental disabilities at our primary site on Front Street. Facility based employment like this is referred to as sheltered employment occurring within a sheltered workshop. Many programs in the state have much more extensive sheltered employment/workshop programs than us. Over the years we have emphasized community based employment making our sheltered employment services a relatively small service option. Policy changes at the State will result in programs like ours no longer being

allowed to provide sheltered employment as of September 2018 which impacts our confidential record destruction operation. For the past several years the State has been emphasizing development of competitive community based employment options for individuals with disabilities in lieu of sheltered employment. We rec-

ognize the impact of this policy change on those receiving these services. After September 2018, individuals affected by this change will continue to receive services at our Front Street facility and be given the option of becoming involved in our employment services program to prepare and support them on a competitive community-based job. Other options would include community inclusion or other day support

services that we provide. We have been meeting with individuals affected during the past year about this change and helping them make choices about future services they desire once sheltered employment services are ended by the State. We are also exploring how we can spin off our confidential record destruction operation to the local business community making that a competitive employment opportunity for those affected. 
